## Pastor Eric's report for the November Council meeting:

- Julie Williams has launched a new devotion writing team and I'm on it. We met with seven people Monday, Nov 10, to set a direction together. We will begin with weekly devotions for the season of Lent in 2026.
- New Members will be received in worship on November 23 and welcomed at the
  community meal afterward. We anticipate 15-20 people will join our congregation on
  Nov 23. After Nov 23, we will publish their names in the E-News. Please go to the effort

- I attended the installation of our new assistant to the bishop, Michelle deBeauchamp on Oct 25 in Aberdeen, WA.
- Deacon Traci and I presided at the graveside of Keith Wright on Oct 28 and memorial service on Nov 1.
- I'm helping to launch a new young adult small group. Clayton and Kathryn Hashley and Kelvin and Angela Machumu are organizing an event at the Hashley house on Thursday, Nov 20 at 6pm. I will be in attendance to help lead them in the specifics of their small group formation.
- Upcoming baptisms: Kiera Swanson, 16 yrs old, will be baptized at the late service on Nov 16. Raydin Riley will be baptized on Dec 14 at the 9:30 unified service. Owen Shephard will be baptized on Dec 21 at the 9:30 unified service. And more baptisms are yet to be scheduled.
- Joan & Russ Hamburg have designated a \$50K gift to Mt View to be used as a scholarship fund for Mt View youth attending college. Jason Cornell, Karen Hansen, Mark & Craig Hamburg, and I are meeting on Nov 13 to discuss the specifics of the scholarship fund.
- The Season of Generosity is two Sunday, Nov 9 and Nov 16. The theme is Duty and Delight. The goal is 120 giving pledges for 2026. This would be an increase of six pledges over last year.
- Mission Endowment Fund Committee is meeting Nov 16 after worship to begin the approval process for 14 applications to are requesting over \$32K. This year the MEF only has \$29K to give away. MEF Comm will need to work to fit all the asks with the \$29K

limit. We will also discuss on Nov 16 if the MEF banquet in 2026 can be funded by the MEF or if this constitutionally is prohibited.
